TOURNAMENT MORNING: Live wells will be checked on the road into Devils Fork launch area. Registration table opens at 4:30am. Everyone must register to get you're paddle. Please be in the water and ready to go when you're number is called. Take off will be safelight with weigh-in at 3:00pm for the first flight, 3:10 second flight, 3:20 third flight and 3:30 fourth flight.

OFFICIAL RULES: The tournament director has the authority to make all decisions. All Federal, State and Local laws must be followed at all times. Each angler is responsible to know any off-limit areas deemed by the Corp. A high standard of sportsmanship is expected of everyone during this event. Boating safety must be observed. A U.S. Coast Guard approved life preserver type III or higher must be on and fastened with kill switch attached at anytime the boat is under way with the gas motor running. Artificial lures only. No live bait. No trolling. No alcohol allowed in the boat or consumed during the tournament. No fishing in the buoys at Devils Fork launch area.

SCORING AND PENALTIES: A limit of 5 bass (Largemouth, Smallmouth, Kentucky) with a minimum length of 12" may be weighed in. Fish will be measured on a flat board, mouth closed and tail pinched. Any fish shorter than 12" will not be weighed. A dead fish penalty of 25lb per each dead fish will be deducted from the total weight. Late to check-in will result in 1lb penalty for each minute late up to 5 minutes. More than 5 minutes will result in disqualification.

PROTESTS AND POLYGRAPHS: Any protest must be presented to the tournament director, in writing, within 10 minutes of scales closing. Any and all contestants are subject to polygraph testing. A refusal to submit to testing will result in disqualification, a failed test will result in disqualification.
